#### **Abstract/Executive Summary.**

The Educational Prairie Trail Project will expand on urban conservation work done through the Urban Woods and Prairies project. The Educational Prairie Trail will include high-diversity plug plantings and interseeding at Urban Plains Park, an extension of the current trail system, and interpretive signage to expand the footprint of prairie in Fargo and provide a central location for education and outreach.

#### **Project Duration:**

July 1, 2024 to June 30, 2027

Site has already been identified, and plans created with United Prairie Foundation, and Fargo Parks District. We anticipate starting work in 2024, and having most reimbursement in 2025. As weather and permitting can delay progress, Audubon proposes a three year project to give project partners time to complete deliverables in the case of any delay.

#### **Narrative**

Organization Information – Briefly summarize your organization's history, mission, current programs and activities.

Audubon Great Plains is the regional program for North Dakota, South Dakota, and Nebraska within the National Audubon Society. Since 1905, the National Audubon Society has been focused on conserving bird habitat, promoting avian education, and engaging individuals and communities in a variety of activities and opportunities. Audubon Dakota as a North Dakota state program was instituted in 1997, however Audubon's role in the Dakotas spans back to the mid-1970s.

The mission of the National Audubon Society is to protect birds and the places they need, today and tomorrow, throughout the Americas using science, advocacy, education, and on-the-ground conservation.

Audubon seeks partnerships that advance its habitat conservation goals, including supporting grassland habitat projects and the ranching industry. Audubon has five full time staff members in North Dakota, and Audubon Great Plains' Advisory Board includes eight North Dakota citizens. Currently, Audubon directly manages roughly 5,000 acres within the state and partners with landowners to inform management on an additional 150,000 acres in North Dakota. In all of our programs, the efforts and cooperation of our supporters is crucial to our success and the conservation of bird habitat in the Great Plains.

### Purpose of Grant – Describe the proposed project identifying how the project will meet the specific directive(s) of the Outdoor Heritage Fund Program

The proposed Educational Prairie Trail will be an extension of the prairie planting around the perimeter of the south section of Urban Plains Park. These plantings provide immediate floral resources in grass-dominated landscapes and, create an Ecological Habitat Area. Ecological habitat areas in city parks provide a location for outreach events and promotion of diverse prairie habitat and wildlife that depends on it.

For Phase 1, the entire west sidewalk of the north section will be planted with native prairie plant plugs, featuring a large percentage of liatris species, which will attract monarch butterflies during their migration period. Within this strip of native plants, a central portion will be densely planted with a high number of species to demonstrate the incredible diversity of native prairies. Additional sections of the west strip will be planted with drifts of individual species and will include signs identifying the plants.

Phase 2 will install more pollinator habitat long the inner trails of the park, and will complete the perimeter of the north section. Ten permanent education signs will be installed along the trails and sidewalks featuring a range of prairie-related subjects. The Educational Prairie Trail will be unique for the Fargo Area, and the state, because it will provide a central location for observing native prairie plants on a self-guided educational trail.

The sidewalk trails will be planted using mature bare root plants and greenhouse grown plugs. Site prep will require herbicide application to eliminate the existing turf, and installation of landscape fabric to prevent weeds after establishment. Additional seed will be added after fabric is removed. Within the inner trail system, herbicide will be used to terminate dominating grasses in strategic areas, and diverse species will be planted to represent different types of prairies (i.e. dry, mesic, moist). The entire Urban Plains Park (12 acres) will also be interseeded with high diverse, local ecotype prairie seed mixes.

The project will expand the footprint of prairie in Fargo and provide a central location for education and outreach. A large portion of this project will be planted with volunteers. United Prairie Foundation will host community outreach events at Urban Plains to plant plugs. This expansion project will also increase opportunities for community seed collection and replanting on-site and in other city parks.

Juli Bosmoe, Senior Range Ecologist for Audubon Great Plains, will lead partnership development and contractor engagement.

Sam DeMarais, Park Forester for Fargo Parks District, will lead development and project planning on UWP sites for Fargo Parks.

John Devries, Project Manager at United Prairie Foundation, will lead project implementation and outreach activities for planting.

The team has already identified a location for the trail, developed a site plan, and engaged partners. The work is slated to start in 2024, with completion in 2025. The team has extensive experience in implementing urban conservation projects and managing contracts and grants associated with habitat restoration and management.

#### Evaluation – Describe your plan to document progress and results.

Audubon Great Plains will work with contractors and partners to ensure the work is completed on time and appropriately. Audubon will report biannually to OHF on project progress and milestones.

Audubon Great Plains and partners will carry out a focused marketing and awareness campaign around this project in order to educate the public on the mutual benefits of native plantings, assuage any concerns relative to the transition of the sites, and ensure increased public usage of the new habitat parks. As proven by existing UWP nature parks, these sites provide incomparable educational opportunities to engage the community. Interpretive signage and programs are aimed at generating greater general understanding of natural resources, management objectives, and increased interest in nature. Public use of the restored sites will be monitored by maintaining lists of participants in outdoor programming, which will be conducted by the landowner partners and Audubon Dakota's Engagement Coordinator.

Budget Narrative – Use the space below to provide additional detail regarding project expenses. The educational prairie trail area in Urban Plains Park will be restored and enhanced throughout the project period. Audubon collected estimates from United Prairie Foundation to calculate the cost of the restoration and management. In total, Audubon is requesting \$149,292 for the development of the Educational Prairie Trail.

The primary costs are for seed and prairie plugs to be placed at the site. \$90,392 is requested from OHF to purchase prairie plugs to plant along the educational prairie trail, with \$26,500 in cash from project partners to purchase the remaining plugs. These plugs will feature local ecotype native prairie forbs that will provide high quality wildlife and pollinator habitat. \$26,500 for seed as well as site prep and interseeding of portions of the park will be covered by other project partners contributing cash listed under matching sources. \$30,000 will be used to extend the existing trail system by 1300 feet, using crushed gravel as a base, by hiring a contractor to complete the project.

Additional funds will be used to extend the existing trail system to allow visitors to explore more of the restored prairie. 1300 feet of trail will be created using crushed gravel at a cost of \$30,000 for a contractor to complete the project. \$4,000 is requested for hosting volunteer planting events, to secure personnel and equipment from United Prairie Foundation to host 250 volunteer hours per year in year 1 and 2 to install the prairie plugs. This volunteer effort will provide \$7,500 in-kind match toward the project, 500 hours at \$15/hour. Audubon requests \$10,000 to cover a portion of the maintenance costs associated with the project over the first

three years, with \$3,500 coming as in-kind from Fargo Parks District to water in the plugs in the first year, and the remaining \$11,000 cash coming from other project partners.

Audubon seeks staff costs of \$14,900, 10% of overall project costs, to cover staff time associated with managing the grant and implementing the project. 10% was used to calculate allowable staff time request as total OHF request is below \$250,000. Audubon will provide \$5,000 in-kind staff labor. Indirect costs at Audubon's NICRA of 25.49% are the remainder of match funds. Note that only the first \$25,000 of the trail extension contract is used to calculate indirect in line with Audubon's NICRA.

#### Sustainability – Indicate how the project will be funded or sustained in future years.

Funding from the ND Outdoor Heritage Fund will support the initial habitat restoration and management of the educational prairie trail. Audubon Great Plains and our partners will be responsible for preparing each restoration site under the guidance of the hired contractor. After restoration establishment, the native vegetation will require less overall maintenance work than what is currently spent on these areas (mowing hours, staffing, fuel, etc.) which has proven to be cost efficient for landowning partners.

In addition to strictly financial funding, Audubon Dakota would promote the use of the areas for outdoor recreation and education. This will help gain public favor of the areas and help assure the sustainability of these sites thr9ough general community approval. Audubon Dakota will also take on administrative tasks such as scheduling contracted management work to ensure the project is completed in a timely manner.

- Staffing or outside consultants except for costs for staffing or an outside consultant to design and implement an approved project based on the documented need of the

- applicant and the expenditures may not exceed 5% of the grant to a grantee if the grant exceeds \$250,000 and expenditures may not exceed 10% of the grant to a grantee if the grant is \$250,000 or less (see Definitions/Clarifications for how this will be calculated);

- Construction or refurbishment of indoor/outdoor athletic courts and sports fields,

- Projects not meeting a minimum funding request of \$2,500.

<u>Building</u> - Defined as "A structure with a roof either with walls or without walls and is attached to the ground in a permanent nature."

<u>Comprehensive Conservation Plan</u> - Defined as "A detailed plan that has been formally adopted by the governing board which includes goals and objectives--both short and long term, must show how this building will enhance the overall conservation goals of the project and the protection or preservation of

<u>New and Expanded Recreational Project</u> means that the proposed building cannot be a replacement of a current building. The proposed building must also be related to either a new or expanded recreational project--either an expansion in land or an expansion of an existing building or in the opportunities for recreation at the project site.

<u>Playground equipment calculation</u> - Only the actual costs of the playground equipment (a bid or invoice showing the amount of the equipment costs must be provided) - cannot include freight or installation or surface materials or removal of old equipment, etc.

Staffing/Outside Consultants Costs - If you are requesting OHF funding for staffing or for an outside consultant, you must provide information in your application on the need for OHF funding to cover these costs. For example, if you are an entity that has engineering staff you must explain why you don't have sufficient staff to do the work or if specific expertise is needed or whatever the reason is for your entity to retain an outside consultant. If it is a request for reimbursement for staff time then a written explanation is required in the application of why OHF funding is needed to pay for the costs of that staff member(s)' time. The budget form must reflect on a separate line item the specific amount that is being requested for staffing and/or the hiring of an outside consultant. This separate line item will then be used to make the calculation of 5% or 10% as outlined in the law. Note that the calculation will be made on the grant less the costs for the consultant or staff.

#### **Awarding of Grants**

All decisions on requests will be reported to applicants no later than 30 days after Industrial Commission consideration. The Commission can set a limit on duration of an offer on each application or if there isn't a specific date indicated in the application for implementation of the project, then the applicant has until the next Outdoor Heritage Fund Advisory Board regular meeting to sign the contract and get the project underway or the commitment for funding will be terminated and the applicant may resubmit for funding. Applicants whose proposals have been approved will receive a contract outlining the terms and conditions of the grant.

#### Responsibility of Recipient

The recipient of any grant from the Industrial Commission must use the funds awarded for the specific purpose described in the grant application and in accordance with the contract. The recipient cannot use any of the funds for the purposes stated under Exemptions on the first page of this application.

## Making Prairie Common Again

Educational Prairie Trail: an accessible, highprofile prairie planting that demonstrates prairie gardens and promotes native plant species

## Project Summary - Phases 1 and 2

The proposed Educational Prairie Trail will be an extension of the prairie planting around the perimeter of the south section of Urban Plains park, pictured to the right. These plantings provide immediate floral resources in grass-dominated landscapes, and fit our definition of an Ecological Habitat Area (EHA). EHAs in city parks provide a location for outreach events and promotion of diverse prairie habitat and wildlife that depends on it.

For phase 1, the entire west sidewalk of the north section will be planted with meadow liatris, which will attract monarch butterflies during their August-September migration period. Within the strip of liatris, a central portion will be densely planted with a high number of

species to demonstrate the incredible diversity of native prairies. Additional sections of the west strip will be planted with drifts of individual species and will include signs identifying the plants.

Phase 2 will install more pollinator habitat along the inner trails of the park, and will complete the perimeter of the north section. Approximately nine permanent educational signs will be installed along the trails and sidewalks featuring a range of prairie-related subjects. The Educational Prairie Trail will be unique for the Fargo area, and the state, because it will provide a central location for observing native, local ecotype prairie plants on a self-guided educational trail.

## **Establishment**

The sidewalk trails will be planted using mature bare root plants and greenhouse-grown plugs. Site prep will require herbicide application to eliminate the existing turf, and installation of landscape fabric to prevent weeds after establishment. Additional seed will be added after fabric is removed.

Within the inner trail system, herbicide will be used to terminate dominating grasses in strategic areas, and diverse species will be planted to represent different types of prairies (ie. dry, mesic, wetlands). The entire park (12 acres) will also be interseeded with high diverse, local ecotype prairie seed mixes.

## **Outreach and Events**

This project will expand the footprint of prairie in Fargo and provide a central location for education and outreach. A large portion of this project will be planted with volunteers. UPF will host several community outreach events at Urban Plains in 2024. This expansion project will increase the amount of habitat where visitors can observe prairie plants, birds, monarch butterflies, and other insects for community science. It will also increase opportunities for community seed collection and replanting on-site and in other Fargo parks.


